Legislative News

Well into the second year of the 134th General Assembly, the Legislative Committee continues to work on several pieces of legislation. The bill on restraining pregnant females amended into House Bill (HB) 1 at the end of last year has become law. Also enacted was Senate Bill (SB) 4, which changed the public records law to include emergency service telecommunicators as individuals whose residential and familial information is exempt from disclosure. Another Senate bill that Governor DeWine recently signed is SB 215. The new law allows anyone over 21, who is not prohibited by federal or state law, to carry a concealed weapon without obtaining a license. The Legislative Committee pushed back hard against the bill as it also eliminated the notification requirement for a person having a concealed weapon to notify officers that they are armed.



The FOP continues to be actively involved in three bills that will protect officers during riots and while making arrests. As a reminder, SB 16, HB 22, and HB 109 enhance penalties for the assault and harassment of officers and their families and for interfering in law enforcement duties. HB 22 and HB 109 have passed the House and have had hearings in the Senate Judiciary Committee. SB 16 has passed the Senate and has had several hearings before the House Criminal Justice Committee. Another bill that followed the riots was a draft police licensing bill. There has not been any movement on the proposal as the chiefs of police and attorney general have pulled their support, commenting that the FOP incorporated changes went too far. The FOP fought to have due process and civil liberties for officers in the proposed bill.

President Wolske testified before the House Insurance Committee on HB 512. The bill would increase the employer's contribution to the Ohio Police and Fire Pension Fund. Legislative Committee Chair Jay McDonald testified in opposition to SB 261, which would shift oversight of the State's medical marijuana program from the pharmacy board to the Department of Commerce. If marijuana is a medicine, it should be treated as a medicine. The Legislative Committee is gearing up to give opposition testimony to SB 288. SB 288 makes significant and wholly unnecessary changes to Ohio's criminal justice system and laws. In the future, we will be testifying in support of HB 607 & HJR 2. They would make public safety a consideration when setting bail.

- ◆ The Virgil McDaniel Award is a statewide recognition of a FOP Member who has demonstrated exceptional valor and/or service to the citizens of State of Ohio by the Fraternal Order of Police Associates of Ohio. This award was named in Honor of Ohio FOP Past President and our current FOP Liaison Virgil McDaniel. Members of the FOP and FOPA can nominate their FOP Brothers & Sisters whom they know go above and beyond the call of duty.

If you know of a member, an associate lodge, or an FOP brother or sister that you feel deserves recognition for their hard work, dedication, or exemplary service please nominate them for one of these awards! State Secretary-Treasurer Report

Greetings! It was great meeting some of you at the Spring Board Meeting recently held at Salt Fork State Lodge. I believe we had a very productive meeting. Below you will find the financial information for first quarter of 2022 along with information discussed at the Spring Board Meeting. Bank Balance from January 01, 2022, to April 30, 2022

General Account

Beginning Balance	\$77,345.30
Ending Balance	\$109,405.30
Difference	+ \$32,060.00

Scholarship Account

Beginning Balance	\$11,563.14
Ending Balance	\$10,188.14
Difference	- \$1,375.00

The General Account increased by \$32,060 due to lodges submitting their Per Capita payments. The Scholarship Account decreased due to the obligation to our scholar winners. We did have \$560.00 in donations to the Scholarship fund from the Zanesville Lodge.

PER CAPITA PAYMENTS

By now, every lodge should have submitted at least their first per capita payment. All payments were due by March 31, 2022 for those members who have paid thus far. It is highly recommended and encouraged that you submit your per capita payment on a MONTHLY basis. This will ensure that those members who have paid show as a member. We cannot verify members for their plates or the education program until we show them as paid through the state lodge. Therefore, if you get in the habit of paying as you go (per month), you will be right on track.

LEADERSHIP MEETING – CONFERENCE

We are looking to have a leadership meeting at the State Conference (Presidents and Secretaries, Treasurers). We would like to show everyone how to use the membership data base for reporting your membership. Please note, that as of now, only secretaries will have the access to this database for your lodge. 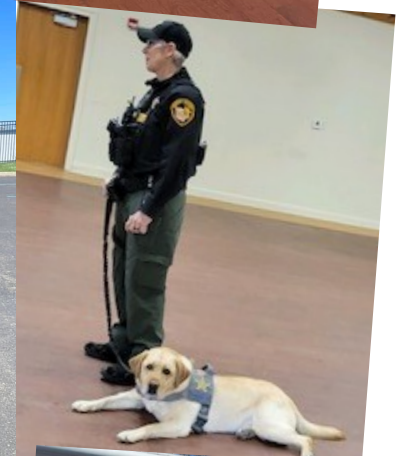

In Memoriam



Donald G. Hall, age 93, died Thursday, April 7, 2022 at Marion General Hospital.

Don was born November 3, 1928 in Marion to the late Clyde and Betty (Ford) Hall. He graduated from Pleasant High School in 1947. He then attended The Ohio State University and also operated a small diner on Marion Waldo Road with his mother. Don met his future wife, Peggy Strobe, through mutual friends.

He was drafted in 1950 to serve in the United States Army during the Korean War and went overseas reporting for duty in Germany. While home on leave, he and Peggy were married on May 13, 1951, now just short of 71 years! When Don was honorably discharged in 1953 he served as a Marion City Police Officer for 8 years and also was a commercial bulk tank milk truck driver prior to beginning a 32 year career with the Marion County Court of

Common Pleas. He served as a Deputy, Bailiff, Probation and Parole Officer, Divorce Commissioner and retired in 1992 as Director of Court Services. Don also worked part time as a real-estate broker ("Hall of Homes") and Home Builder.

He was a member of Emanuel Lutheran Church, F.O.P.A. (former State President), Elks Lodge, Moose Lodge, Gyro, Eagles, VFW, American Legion, Korean War Vets, Marion County Veterans Commissioner, Mason of Grand Lodge #70 (former Grand Master), Shriners (drove a clown parade car), Board of Realtors, Chamber of Commerce, Marion Country Club, OSU Alumni Association, and Rotary (former President).

Don enjoyed their grandchildren and great grandchildren, golfing (including 2 holes in one), OSU Football, summers in Michigan with the Luse family and spending winters in Florida.

He is survived by his wife, Peggy Hall; son, Larry (Linda) Hall of Marion; daughter, Cindy (John) Titus of Delaware, OH; 3 grandsons: Barrett (Sara), Brennan (Serina), Brice (Kendra) Hall; 3 granddaughters: Lynnsey, Shelly (Darrell Tiller), and Chelsea Williams; and 8 great grandchildren. Don is preceded in death by 4 brothers: Billy, John, Bob and Jerry.
